VICTORY IN THE COURT OF APPEAL IN A HEADLINE CIVIL PARTNERSHIP DISPUTE

Another year, another landmark litigation win: Bever achieved victory in the headline case *Roocroft v Ball*, with the Court of Appeal ruling that Roocroft had the right to argue for her civil partnership dissolution settlement to be set aside, the first case to consider the discovery of non-disclosure of assets following the death of one of the parties.

The judgment in *Roocroft* was handed down a year after Bever was also successful in the Supreme Court representing two wives – Varsha Gohil and Alison Sharland – who challenged their divorce settlements after their husbands were found to have misled them significantly regarding their wealth.

Says the client: 'Many hurdles have been thrown our way but Ros was never deterred.'
