Lewin's superb efforts on behalf of this giant and at times amorphous global firm paid off in magnificent style in 2002. He has presided over a three-year growth that now sees the London office as the biggest and most profitable of all the Baker & McKenzie operations.

Lewin had much against him when he took over the job: Baker & McKenzie has never shaken off the perception in the UK market that it is an international giant simply not in the same ilk as a Clifford Chance or a Shearman & Sterling; that it was a mid-level performer in many markets. Lewin focused on maximising the market strengths of his leading practices, and by encouraging such growth, allowed momentum to build.

Crucial to this was making Baker & McKenzie's formidable US client base appreciate the talents available in London, and to provide the UK operation with top-level work. The aforementioned results are testament to the success over which Lewin has presided. Over and above the hard figures, Lewin has also reinvigorated the London office, creating in the process a far more united culture

### **VIRGINIA GLASTONBURY**

**Chief executive, Denton Wilde Sapte**

Glastonbury has been instrumental in awakening the potential in Denton Wilde Sapte since her election to the post of chief executive in February 2002. She now presides over a firm confident of its positioning and future in the international market. Her ascension at the firm comes from

solid foundations: she joined it as an articulated clerk in 1980 and has stayed loyal throughout her 23 years, acting as a strong role model for female lawyers within the firm and beyond.

On becoming Denton Hall's managing partner in 1999, she then oversaw the merger with Wilde Sapte, and retained her role in the merged firm. Her titular change is a result of a streamlined management system that came into force early last year, and from which the firm can only gain further strength in its sensibly balanced cross-section of City and international practice areas. **LB**

### **Tony Angel Managing partner, Linklaters**

In adverse conditions for an elite corporate-focused firm, Angel has bravely rebranded and modernised one of the world's most famous law firms, and given all levels of staff and partners the opportunity to create a far more dynamic global powerhouse.
