A LANDMARK DIVORCE JUDGMENT IN THE SUPREME COURT

Bever was engaged in two of the standout divorce cases in 2015, the successful *Sharland* and *Gohil* Supreme Court divorce challenges, which were heard simultaneously in June 2015.

The Supreme Court ruled in favour of both Alison Sharland and Varsha Gohil, giving them the right to revisit the unjust divorce settlements that had been based on a material failure by their respective husbands to disclose the true extent of their wealth. It was the first time in a generation that the

highest court in the land heard cases on the issue of non-disclosure in divorce proceedings.

The victory on behalf of Gohil was especially impressive, given that her application to extend her legal aid had been rejected on the grounds that her appeal had poor prospects of success.

Testimony from Gohil of the work done by Bever and her team is particularly persuasive, with the client stating after the judgment: 'All spouses subject to deceit and deliberate financial skulduggery in a divorce owe a huge debt of gratitude to the tireless efforts of the legal team here today.'
