THE FIRM

The firm also acts for Maxis Communications Berhad, Astro All Asia Networks Ltd, South Asia Entertainment Holdings Ltd, Mr Ralph Marshall and Mr T Ananda Krishnan following the filing of a charge sheet before the 2G Court in New Delhi, in a dispute relating to investments in India which today amount to in excess of US\$12.01bn. The firm is also involved in two investment treaty claims arising from this principal dispute against the government of India.

More recently, the firm has acted as amicus curiae for the Association of Private Hospital Malaysia in several appeals before the Federal Court of Malaysia relating to the test applicable to doctors and private hospitals in claims for medical negligence where issues pertaining to vicarious liability and non-delegable duty are being raised for the first time.

The firm has also been instructed as counsel for the Majlis Ugama Islam Pahang in respect of appeals brought by Far East Holdings Berhad wherein the applicable test relating to the setting aside of an arbitration award under s37 and s42 of the





Arbitration Act 2005 along with the power of an arbitral tribunal to award pre-award and post-award interest are being determined for the first time by the apex court in Malaysia.

Of late, the firm has successfully acted for the Council of Regency in opposing a claim by Tengku Abdul Halim in relation to succession to the throne of the Sultan of Terengganu.

The firm has also been recently engaged to act as counsel in a pending appeal before the court of appeal for a large firm of accountants in a dispute instituted by bondholders for negligence wherein judgment in excess of RM150m has been entered against the lead arranger, the trustee and the said accounting firm.

The firm has also been engaged by a prominent food franchise in Malaysia in a corporate dispute between its shareholders and directors which involves its holding company and subsidiaries.

The firm continues to advise MRCB George Kent Sdn Bhd, the project delivery partner in so far as the MRT 2 Project in Malaysia is concerned.

Tan Sri Dato' Cecil Abraham continues to sit as arbitrator on a number of investment treaty disputes and international commercial arbitrations.
