### Detailed submission guidelines

For the submission, please provide the following:

#### Contact details

Please provide the name, firm name and practice area(s) for the person put forward as Green Ambassador. Please also provide contact details for arranging a follow-up on the submission.

#### Practice overview

This section should focus on your sustainability-related work for clients. Please provide a description of your core areas of strength and any new areas of focus. Please avoid lengthy paragraphs and avoid unsubstantiated claims.

#### Engagement overview

This section should focus on your sustainability-related engagement beyond your work for clients. This can include both internal initiatives within your firm and external activities. Please state any relevant internal roles in addition to your legal work. Please list any thought leadership, pro bono work, partnerships and memberships in related organisations, associations and alliances, or any other client services or outreach beyond your mandates.

#### Active clients

This should be a list of active, publishable and/or confidential clients.

#### Detailed work highlights

Please provide details of up to 5 transactions, cases or other work. These mandates should be matters which you consider to be significant and most representative of your range of expertise. In each instance, please identify the client, a description of the matter and your role, and mention deal value and start/end dates. The focus is on recent work. If you think older work is significant – or would help us better to understand your practice – then please do mention it and explain why it is of interest.
